

What is Title I?

Martin Technology Academy is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support state and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must jointly develop, with parents and family members, a written parent and family engagement policy.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Martin Technology Academy of Math and Science will provide opportunities to improve family engagement to support student learning. Martin Technology Academy values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Martin Technology Academy will support parent and family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it revised?

Martin Technology Academy invited all parents to attend our annual Parent and Family Input Meeting in the spring to review and revise this parent and family engagement policy, as well as the schoolwide plan, our school-parent compact, school comprehensive needs assessment, and the family engagement budget. Additionally, parent input and comments regarding this plan are welcome during the school year through an online form. The plan is posted on our school website for parents to view and to submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Martin Technology Academy will provide full opportunity for the participation of parents and family members with limited English, with disabilities, and of migratory children.

Where is it available?

After the plan is revised each fall, a link to the plan is distributed to all parents via Infinite Campus email and Remind 101. The plan will also be posted on the school website and social media. Parents can also retrieve a printed copy of the plan in the Parent Information Center in the lobby of the school.

District Goals 2025-2026

FY26 Goal 1: By the end of FY26, the percentage of all students moving into the “Proficient and Distinguished”(combined) levels of performance on the Georgia Milestones Assessments will increase by 2%.

FY26 Goal 2: By the end of FY26, increase the percentage of referred students who access school based mental health services in order to increase the overall school climate rating for HCSD by 1% (from 86.74 to 87.74).

School Goals 2025 - 2026

During the 2025 - 2026 school year, the median growth percentile on the MAP Assessment in the area of ELA will increase by 3% from the 39th percentile to the 42nd percentile when comparing spring 2025 to spring 2026 performance.

During the 2025 - 2026 school year, the median growth percentile on the MAP Assessment in the area of Math will increase by 3% from the 35th percentile to the 38th percentile when comparing spring 2025 to spring 2026 performance.

School-Parent Compacts

As part of this plan, Martin Technology Academy and our families will develop a school-parent compact, which is an agreement that parents, teachers, and students will develop that explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compacts will be reviewed and updated annually based on feedback from parents, students and teachers during the Title I Parent and Family Input Meeting. The school- parent compacts are kept in the main office if parents need a copy.

A celebration of MTA cultures that engages families. There will be food samples, cultural presentations, and hands-on activities for families to take part in.

MAP Testing Informational Meeting – Thursday April 2nd - 8:00 am

Learn from our Principal, Assistant Principal, and Instructional Coach about how to read the MAP Family Report, how we use MAP data to best meet the needs of learners, and how you will know if your student has made progress in growth and achievement.

Title I Parent and Family Input Meeting – April 2nd - 8:30 am (in person) & 5:00 pm (virtual)

Principal, staff and parents review and revise the school wide plan, parent and family engagement policy, school-parent compacts and the parental involvement budget for the 2025-2026 school year. We'll also host a discussion of Summer Reading Programs and Library Resources available over the summer!

Keeping Parents Informed

Martin Technology Academy will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will take the following actions:

- Ensure that all information related to school and parent programs, meetings, and other activities will be communicated to parents in both English and Spanish.
- Survey parents annually to share their perceptions of the school and suggestions for improvement.
- Inform parents of school news, reports, and other items of interest through school-wide emails, phone calls, social media, and written communication.
- Maintain contact with our parents through the use of student agendas, newsletters, Infinite Campus and work folders. Parents are also encouraged to use email to ask questions and inform the teacher of things that may be beneficial to your child's education.
- Maintain an updated web site with parent information including newsletters, Title I Plan, Parent and Family Engagement Policy, School Improvement Plan, photo galleries, teacher web pages, and calendar of events, lunch menus, and helpful links for parents and students in both English and Spanish.
- Partner with Head Start through the District Parent Outreach Facilitator. The District Parent Outreach Facilitator meets with parents and families providing information and resources to support school orientation for parents, families and students to assist in successful student transitions to kindergarten.
- Canvas professional development modules are used, at least four times a year, to train school personnel about strategies to improve communication with parents and ideas to increase family engagement.
- Provide parents with family meetings to share understandable information, strategies, and materials to be utilized at home to help students master grade-level standards and achieve personal and schoolwide goals.
- Partner with middle schools to provide students and parents resources and information pertaining to successful transitioning to middle school.
